# WHO launches Toolkit for the investigation of sexual violence in conflict settings

In the past 20 years, increasing attention has been paid to ending impunity for perpetrators of sexual violence in conflict-affected settings and to achieving assistance and



justice for victims. It is acknowledged that this is an important part of the response to sexual violence. While there have been significant advances, there remains a lack of clarity about what medico-legal evidence should be collected to support national and international criminal justice processes

Medico-legal evidence is at the intersection of medical and justice processes and appropriate implementation requires coordination between the range of actors and sectors involved in prevention of, and response to, sexual violence; these include health services, social services, forensic medicine, forensic lab services, police/ investigation, and the legal system, including lawyers and judge

This toolkit is practitioner focused and addresses key knowledge gaps within and between sectors, to help support service provision and coordination in low-resource settings. It is part of a World Health Organization (WHO) and United Nations Office on Drugs and Crime (UNODC) Project on Strengthening Medico-Legal Services for Sexual Violence Cases in Conflict-Affected Settings, supported by United Nations Action against Sexual Violence in Conflict (UN Action).



# UPDATE OF ACTIVITIES IN SOUTH ASIA, SOUTH EAST ASIA AND THE PACIFIC - August - October 2015

## Afghanistan and Pakistan

The ICRC organized with the Ministry of Public Health and the Forensic Medicine Directorate in Kabul, the 1st Workshop in Forensic Medicine. The week long workshop, facilitated by Professor Stephen Cordner of the Victorian Institute of Forensic Medicine, for medical specialists and trainees from across the country to promote core principles for decedent documentation, the identification process and determination of manner of death.

The ICRC held its 11th National Course on the Management of the Dead in Emergencies in Karachi to responsible stakeholders. The 5 - day course was attended by 24 participants from different national authorities, agencies and organizations, including the Provincial Disaster Management Agency, Fire Brigade, Sindh Police, Combined Military Hospitals Malir and Quetta, among others.

The ICRC announces the1st International Course on the Management of the Dead will take place in Islamabad from August 1-5, 2016. The course is open to national stakeholders who manage the dead in their respective countries. Interested participants must apply through the relevant ICRC delegation. Space is limited, so early applications are recommended.

## Sri Lanka and Bangladesh

The ICRC is working with the College of Forensic Pathologists (presided by Dr.AjithTennakoon, Chief Consultant JMO and APMLA Board Member), the University of Colombo and the Institute of Forensic Medicine & Toxicology to develop an MSc in Forensic Anthropology & Archaeology and accompanying teaching and working laboratory. The ICRC is also contributing to the work of a Committee established by the Minister of Justice to recommend reforms to the laws, procedures and practices relating to conduct of Inquests of Deaths. In Bangladesh, the ICRC supports the Ministry of Disaster Management & Relief to develop guidelines on the management of the dead from disasters. These guidelines will form part of a comprehensive program in Bangladesh, involving the Ministry and other concerned stakeholders, to ensure that the



dead are appropriately and professionally managed with dignity, to promote the identification of the dead and return of their remains to their families."



## Nepal

In response to the earthquake that struck Nepal on 25 April 2015 which claimed the lives of 8974, the ICRC supported the Department of Forensic Medicine (DFM) for the management of the dead under very challenging circumstances. The activities and contributions include to put in place operational modalities for dignified management of the dead (DMD), provision of required materials and equipment (e.g. body bags and related disposables, some mortuary instruments),training to local forensic practitioners on Forensic Pathology and Forensic Anthropology, a refrigerated container was provided for the storage of bodies as an immediate response, improving IT capabilities (laptops, printer, AM/PM database), update of the filing system for records and documentation, and the design and construction of a larger capacity cold room for body storage which was inaugurated and commissioned for use at the end of October,2015. Dr.Uwom Eze (Nigeria) has been appointed as the ICRC Forensic Coordinator to Nepal.

## Timor Leste, Indonesia and Korea

The ICRC organized in August, in cooperation with the Hospital Guido Valladares in Dili (Timor Leste) the 1st Introductory Course in Forensic Medicine; a two day course facilitated by Dr.Nuno Duarte Vieira of the University of Coimbra (Portugal), for medical staff, police investigators from PNTL and the newly formed PCIC from Timor Leste promote core principles for decedent



documentation, the identification process and determination of manner of death. The course will be replicated in 2016. In September the ICRC organized a Regional Workshop on the Management of the Dead in Disasters and the Asia Pacific Medico Legal Agencies (APMLA) Annual Meeting, at the Jakarta Center for Law Enforcement Cooperation (JCLEC) in Semarang, Indonesia. This event took place in cooperation with the APMLA, the Australian Federal Police (AFP), and the support of the Victorian Institute of Forensic Medicine (VIFM). Representatives from at least 18 countries, national organizations and RC&RC National Societies attended.

The ICRC met in October for the first time the National Forensic Service (NFS) and MAKRI in Seoul (S.Korea), in order to identify possible venues for technical cooperation in the wider Asia region.


## APMLA Annual Ceneral Meeting Report 23 September 2015



This year's Annual General Meeting of the APMLA was held in conjunction with a two - day ICRC Workshop on the Management of the Dead Following Disasters which was held at the Jakarta Centre for Law Enforcement Cooperation (JCLEC) in Semarang, Indonesia. The APMLA is very appreciative of this training collaboration with the ICRC and in particular for its travel support for many of the attendees. The workshop and APMLA meeting attracted 41 attendees from a range of nations including Cambodia, Korea, Indonesia, Thailand, Fiji, Malaysia, India, Sri Lanka, Australia, Papua New Guinea, Nepal and Japan. Please note that this is an overview of the APMLA meeting and full meeting minutes have been distributed to member institutions.

## APMLA Work Group: Advocacy for Forensic Medical Development in the Asia Pacific

## Approach)

The advocacy approach will be considered on two levels: at an organisation to organisation level and then in terms of resource development for APMLA memberinstitutions to support advocacy for capacity development in their own jurisdictions.

1. Consider the role for the APMLA in liaising with and influencing international organisations such as the ICRC, ASEANAPOL, INTERPOL, the WHO, UNDP and the UNODC and develop some agreed APMLA priorities. For example in encouraging ASEANAPOL to consider the promotion of first responder training in Dead Body Management to its 10 country-member police forces.

APMLA member institutions may be able to play a role in training provision for police in their jurisdictions.

Develop advocacy materials which can be used by member institutions to lobby Governments and other donors for improved forensic medical resourcing and better policy outcomes in their own jurisdictions.

## Objectives:

- To facilitate mutually productive relationships between APMLA and its members and relevant international organisations.
- To support APMLA members in the development of improved advocacy skills and materials for better resourcing in their own nations.

## Work Plan

Draft proposed forensic medical capacity development priorities that are relevant to each of the international organisations ICRC; ASEANAPOL; INTERPOL; WHO; UNDP and UNODC and outline the possible role for the APMLA and method of approach. Provide to the Executive Committee for consideration.

Identify core forensic medical training or infrastructure priorities such as mortuary upgrades and training in medico-legal reporting and provision of expert opinions and prepare generic papers which outline the benefits to the justice system, the community which can then be tailored to meet individual jurisdictional requirements and language (no. of staff to be trained and cost etc.). Provide draft documents to the Executive Committee for comment.

## Outputs:

- Improved mutually beneficial relationships between the APMLA and its members and identified international agencies.
- Improved institutional capacities.
- A set of materials that outline the community, health and justice system and disaster preparedness benefits of having robust forensic medical systems and professional staff.






